### **FIRST YEAR DIPLOMA IN PHARMACY (D. PHARM.)**

The candidates should be an Indian national.

Candidate should have passed the HSC examination with Physics & Chemistry as compulsory subjects along with one of the subjects Mathematics or Biology (Botany & Zoology).

### **FIRST YEAR BACHELOR OF PHARMACY (B. PHARM.)**

Candidate should have passed the HSC examination or its equivalent examination with Physics & Chemistry as compulsory subjects along with one of the subject Biology / Mathematics / Biotechnology & obtained minimum 45% marks (at least 40% marks in case of Backward Class category and person with disability from Maharashtra State only) in the above subjects taken together. Candidate should have obtained score in MHT-CET2016.

### **DIRECT SECOND YEAR BACHELOR OF PHARMACY (B. PHARM.)**

**(Lateral Entry):** Candidate should have passed Diploma in Pharmacy with at least 45% marks (at least 40% marks in case of Backward Class category and person with disability from Maharashtra State only) from AICTE/PCI approved institution.
